Fees

The Mare Owner agrees to pay a non-refundable Stallion Service Fee of £500 which must be received before semen is released.

A covering certificate will be issued to the Mare Owner and the Stud will furnish all necessary paperwork for registration to the Irish Draught Horse Society (G.B.) and any other registry at the Mare Owner's request.

Shipping

The semen is kept and stored by Stallion AI Services (01948 666295). The Mare Owner should fill out a semen order form on the Stallion AI Services website (http://stallionai.co.uk/order-semen/). Once the semen has been paid for it will be released. Shipping charges are approximately £180, which includes next day delivery and return of the shipping container. All shipping fees are paid to Stallion AI Services. The Stud accepts no responsibility for the shipping of semen once permission to release the semen has been communicated to Stallion AI Services.

Semen Evaluation

The most recent evaluation of this semen undertaken by Stallion AI Services (July 2020) found the thawed semen to be approximately 30% progressively motile. Ten straws constitutes one insemination dose of Banks Fee Daniel semen.

Doses

Semen will be released one insemination dose at a time. The first and second doses are included in the price of the stud fee. A third dose may be purchased for an additional £200 if the mare fails to take on the first two attempts.

Non-Assignment

This contract cannot be assigned or transferred by Mare Owner. There shall be no right of return to the Stallion if the Mare is sold or otherwise changes ownership after having been serviced by the Stallion without express consent from the Stud.

Additional Notes

- a.) This agreement must be completed and furnished to the Stud before semen is shipped. This is a great aid in accuracy of covering certificates.
- b.) By inseminating, The Mare Owner and/or Mare Owner's agent and/or attending veterinarian confirms the semen is of *at least* acceptable quality.
- c.) This agreement will last until August 31 two years from initial signing. Any change to the agreement must be made with permission from the Stud and Mare Owner.
- d.) Any unused semen is to be returned to Stallion AI Services within the breeding season.
