Collections

Collections are available 5 days a week. 24 - 48 hr. notice is appreciated. No collections can be scheduled after 9:30 a.m. sharp on the day of the collection.

Collections will usually be shipped by Royal Mail for the earliest next day delivery time available. The Stud accepts no responsibility for any delays in shipping once the semen has been dispatched.

No Foal Free Return Policy

If the Mare is barren, aborts, or fails to produce a single live foal, the Stud will allow the Mare Owner a return breeding privilege of the Mare (or a substitute mare) to contracted Stallion either the same or the next breeding season, provided the Mare Owner furnishes a satisfactory certificate issued by a licensed veterinarian attesting to such fact within 30 days of the attempted breeding of barren mare, the abortion, or the natural death of the foal within the first two weeks after foaling.

Non-Assignment

This contract cannot be assigned or transferred by Mare Owner. There shall be no right of return to the Stallion if the Mare is sold or otherwise changes ownership after having been serviced by the Stallion without express consent from the Stud.

Additional Notes

- a.) This agreement must be must be completed and furnished to the Stud before semen is shipped. This is a great aid in accuracy of covering certificates.
- b.) By inseminating, mare owner and/or owner's agent and/or attending veterinarian confirms the semen is of *at least* acceptable quality.
- c.) This agreement will last until August 31 two years from initial signing. Any change to the agreement must be made with permission from the Stud and Mare Owner.
